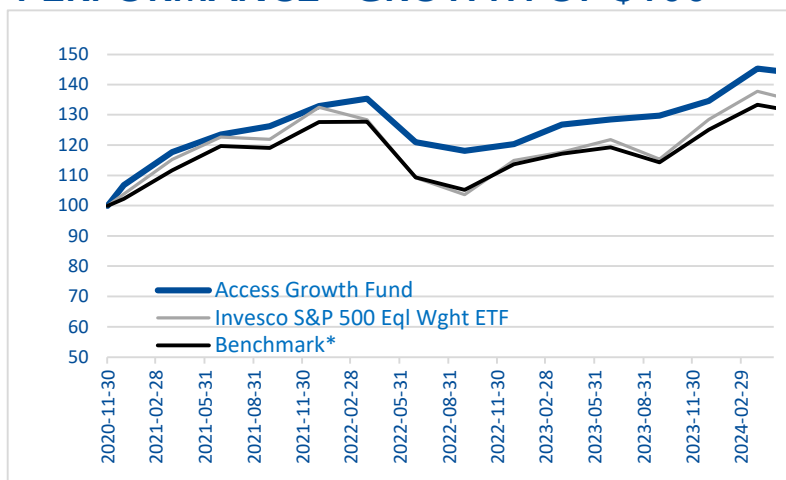
INVESTMENT STRATEGY
