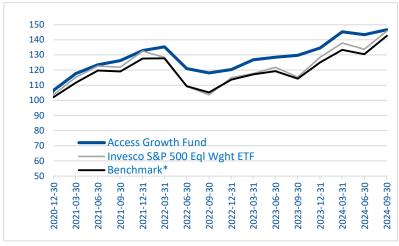
INVESTMENT STRATEGY

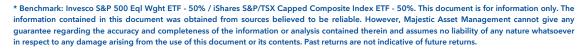
