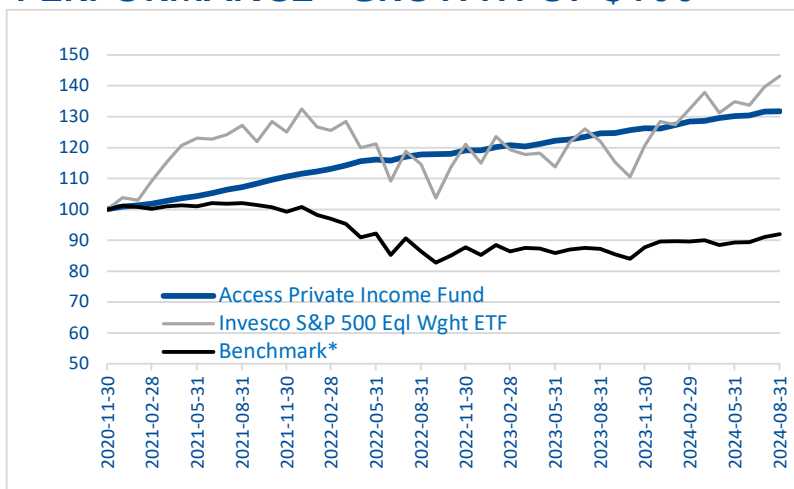
### INVESTMENT STRATEGY
